CRIF Study: on Swiss cancelled companies: a hige decrease in 2029

Zurich, 9th January 2020 – In 2019 founded 44.616 new companies, with 3.3% increase versus 2018. On the other side, cancelled companies were 12.7% versus 2018. Net growth reported is a decrease of 14%.

CRIF AG analyzed number of companies created in 2019 and number of companies cancelled in the same period. In the considered year, in Switzerland opened 44.616 new business with a 3.3% increase compared to previous year. During the same period, 31.265 Commercial Registry reported 31.265 cancelled companies, with an increase of 12.7% compared to 2018.

Increase in cancelled companies affected also net growth of the companies. Even if in 2018 less new companies were registered compared to 2019, net growth was of 15.450 firms. Instead, on 2019 net growth was of 13.351 units, with a 13.5% decrease.

Higher number of new registrations is reported in Canton of Zurich (7,861), Vaud (4,653) and Genève (3,864). If compared to 2018, cantons with an higher growth were Berne (+338), Vaud (+272) and St. Gallen. Opposite trend in Zug (-217), Appenzell Ausserrhoden (-49) and Obwalden (-22).

Considering overall Switzerland, number of companies increased of 2.3%. Highest increase in Canton of Thurgau und Luzern (3.5%), then Canton of Zug (3.3%), finally Canton of Aargau (3%). Negative data in Canton of Obwalden (-0.4%).

Looking at the individual sectors, management consultancy (3,382) shows the higher number of start-ups followed by retail trade (3,083) and construction (3,060). In terms of cancellations, the retail trade recorded the highest number (3,284), followed by construction (2,743) and wholesale trade (2,652).

The sectors with the highest net growth are the consulting firms (1,697), the real estate (1,306) and the healthcare (1,185). Wholesale trade (-413), catering (-257) and retail trade (-201) recorded a decline in overall number.

About the survey process

All companies that were newly entered in the Commercial Register between 1 January 2019 and 31 December 2019 as well as all companies that were deleted from the Commercial Register during this period were taken into account. For example, a company can be deleted by default, when the bankruptcy proceedings are closed, at the end of the liquidation period, then in the case of mergers or in the case of company tasks due to the lack of succession regulation.



In 2019 cancellations strongly increased, with 12.7%. It's linked to a decrease in net growth versus previous year, despite in 2018 less companies were created.


